The U.S. Trade and Development Agency (USTDA) is hosting a two-day workshop to explore business opportunities in Thailand's healthcare sector as the country works to establish itself as a leading medical hub for innovative and modern healthcare. It will be live streamed for registered virtual participants.

BACKGROUND

The workshop, hosted by USTDA in partnership with the American Chamber of Commerce in Thailand (AMCHAM) and the Eastern Economic Corridor Office of Thailand (EECO) in Bangkok, will focus on exploring the Thai government's "Thailand 4.0" initiative, which aims to transform the country into a hub for innovation and value-based industry.

Participants will learn about the challenges and solutions for adopting cutting-edge technologies and promoting innovation in the healthcare sector. It will also be an opportunity to discuss how U.S. technologies can help drive commercial engagement, lead to better health outcomes for patients, and support innovation to advance Thailand 4.0.

- Policies and incentives to position Thailand as a world-class healthcare service hub
- Thailand's outlook on healthcare investment and public expenditures
- Regulatory and market access challenges in Thailand

- U.S. industry recommendations on innovative financing models
- Value-based healthcare transformation opportunities in Thailand
- Best practices in global pricing and reimbursement strategies

This workshop is the second in a series of five USTDA-hosted healthcare workshops in Southeast Asia to provide policy-focused education and training to healthcare stakeholders.
