## Build U.S.-India Civil Aviation Partnerships

The 7th U.S.-India Aviation Summit will convene roughly 250 U.S. and Indian government and industry leaders for a multi-day event in Washington, D.C. Through sessions on topics from airspace capacity, cargo and security to sustainability technology and more, the Summit will foster dialogues on civil aviation and serve as a showcase for advanced U.S. technology, equipment, services, and best practices that can be tailored to further India's key aviation and airport projects.

### BACKGROUND

The U.S. Trade and Development Agency (USTDA) will host the U.S.-India Aviation Summit in partnership with India's Ministry of Civil Aviation to advance aviation policy cooperation and to build commercial partnerships.

Over the last decade, India's civil aviation industry has experienced expansive growth, and projections agree that demand will continue to grow. The Indian government has committed \$12 billion over two years to construct new airports and updating existing ones, presenting enormous opportunities for U.S. companies working in the area of airport and aviation infrastructure.

The U.S.-India Aviation Summit sits at the meeting point of innovation and collaboration, catalyzing partnerships for action. In addition to serving as a forum for dialogue, the Summit will showcase advanced U.S. innovations. It will feature extensive networking opportunities with key stakeholders, and provide invaluable information on market expansion strategies, government initiatives, and industry trends.

The Summit is being hosted under USTDA's U.S.-India Aviation Cooperation Program, a partnership that convenes the U.S. government and U.S. industry to collaborate with India on programs designed to match India's aviation needs with U.S. private sector expertise and innovation.
