

**Official Drawing Rules
Minnesota State Lottery
True North™ Second Chance**

January 5, 2021; Amended April 1, 2021; April 5, 2021; Revised September 1, 2021

1.1. Definitions

- A. **“True North”** or **“Scratch Ticket”** or **“Ticket”** means the Minnesota Lottery Scratch Game #1840.
- B. **“True North Second Chance”** means an additional opportunity to win through a drawing conducted by the Minnesota Lottery in conjunction with the purchase of a True North Scratch Ticket.
- C. **“The Lottery”** means the Minnesota State Lottery.
- D. **“True North Second Chance Promotion”** or **“Second Chance”** means the drawings conducted by the Lottery in conjunction with the True North Second Chance Promotion.
- E. **“Account”** means a player has registered at mnlottery.com with all required personal contact information.

2.1. Duration

The True North Second Chance will begin at 9:00:00 a.m. Central Time (“CT”) on January 5, 2021, and conclude at 11:59:59 p.m. CT on ~~a date to be determined (“TBD”) by the Lottery~~ June 8, 2021.

3.1. Eligibility

- A. A player may enter the True North Second Chance by creating or having an Account at mnlottery.com, supplying all required registration information completely and in its entirety, and entering the 10-digit second chance code found under the scratch-off latex coating of the 2nd chance logo of a non-winning True North Scratch Ticket. Incomplete registration information may result in entry disqualification.
- B. Each non-winning Ticket entered will receive one (1) entry in the True North Second Chance.
- C. Only one (1) winner per household is permitted.
- D. The submission of a winning Ticket invalidates that entry.
- E. Employees (including immediate family residing in the same household) of the Lottery, employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from the True North Second Chance.

- F. A player who submits an entry must be 18 years of age or older.
- G. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.
- H. A player may enter more than once; however, a player may use only one (1) unique Ticket number per entry. Multiple entries using the same non-winning Ticket number and entries made via automated computer scripts or other programming techniques will be disqualified.
- I. A player who uses a non-winning Ticket as an entry in this True North Second Chance that has previously been used in any other Minnesota Lottery Second Chance, sweepstakes, or contest will be considered ineligible.
- J. By participating, players agree to these official rules and to the decisions of the Lottery which will be final and binding in all respects.
- K. An entry will be considered invalid if it does not meet all requirements for eligibility stated in this section.

4.1. True North Second Chance Drawings

- A. To enter the True North Second Chance, a player must enter a non-winning Ticket via the process described above. The Lottery will conduct three (3) True North Second Chance drawings. The eligibility and schedule for each drawing are listed in the table below.

- B. The Lottery will, by use of mechanical or other devices, randomly determine which of the entries submitted are selected.

- C. The Lottery will conduct three (3) drawings at Lottery Headquarters. A Lottery representative will draw forty-four (44) total winners for the following prizes:
- One (1) prize of \$5,000 in cash (\$5,000 taxable value)
 - One (1) prize of \$2,000 in Freewheel Bike gift cards and \$1,000 in Visa gift cards (\$3,000 taxable value)
 - Two (2) prizes of \$2,000 in Freewheel Bike gift cards and \$1,000 in cash (\$3,000 taxable value)
 - Thirty (30) prizes of \$500 cash and an adventure pack that consists of one True North canteen, one True North coffee sleeve, one pair of Sota Clothing socks, one Minnesota Lottery-logo puzzle, one Minnesota Lottery-logo knit hat, and one Minnesota Lottery-logo ice scraper. (\$527.48 taxable value)
 - Ten (10) prizes of \$500 cash and an adventure pack that consists of one True North canteen, one True North coffee sleeve, one pair of Sota Clothing socks, one Minnesota Lottery-logo puzzle, one Minnesota Lottery-logo collapsible cooler, and one Minnesota Lottery-logo fanny pack. (\$527.48 taxable value)

The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

- D. The first (1) entry drawn in Drawing #1 will receive one (1) \$2,000 gift card to Freewheel Bike and one (1) \$1,000 Visa gift card. The next fifteen (15) entries drawn in drawing #1 will receive \$500 cash and an adventure pack that consists of one (1) True North canteen, one (1) True North coffee sleeve, one (1) pair of Sota Clothing socks, one (1) Minnesota Lottery-logo puzzle, one (1) Minnesota Lottery-logo knit hat, and one (1) Minnesota Lottery-logo ice scraper.
- E. The first (1) entry drawn in Drawing #2 will receive one (1) \$2,000 gift card to Freewheel Bike and \$1,000 cash. The next fifteen (15) entries drawn in Drawing #2 will receive \$500 cash and an adventure pack that consists of one (1) True North canteen, one (1) True North coffee sleeve, one (1) pair of Sota Clothing socks, one (1) Minnesota Lottery-logo puzzle, one (1) Minnesota Lottery-logo knit hat, and one (1) Minnesota Lottery-logo ice scraper.
- F. The first (1) entry drawn in Drawing #3 will receive \$5,000 cash. The next one (1) entry drawn in Drawing #3 will receive one (1) \$2,000 gift card to Freewheel Bike and \$1,000 cash. The next ten (10) entries drawn in Drawing #3 will receive \$500 cash and an adventure pack that consists of

one (1) True North canteen, one (1) True North coffee sleeve, one (1) pair of Sota Clothing socks, one (1) Minnesota Lottery-logo puzzle, one (1) Minnesota Lottery-logo collapsible cooler, and one (1) Minnesota Lottery-logo fanny pack.

- G. A player may win only once in each True North Second Chance drawing, and cannot win a prize in more than one drawing.
- H. A list of all prizewinners will be posted on the Winners page of mnlottery.com following the drawing and after prizewinners have been verified. The list will remain on the Winners page for the duration of the Claim Period (as defined below).
- I. By entering the True North Second Chance, prizewinners [of prizes valued at \\$599 or less](#) consent to full use of any and all information they provide on their entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

4.2. **Claiming Prizes**

- A. A prize won in a Second Chance may not be assigned or transferred to another person. A merchandise or experiential prize may not be shared with another person under a prize-sharing agreement. A cash prize of \$600 or more may be split with another person under a prize-sharing agreement. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply.
- B. Prizes with a value of \$599 or less will be shipped to the address listed in the prizewinner's Account after the drawing in which they are awarded. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service mailing address, and for checking mnlottery.com to determine if a prize was returned to the Lottery.
- C. Each player whose entry was selected in a Second Chance drawing to win a prize valued at \$600 or more must fill out and submit a Winner Affidavit form to the Lottery. If the claim is not validated by the Lottery, the claim will be denied, and the player will be notified immediately.

1. For the \$5,000 prize, if the prizewinner is delinquent in the payment of Minnesota state taxes or owes a debt as defined in Minn. Stat. § 270A.03, subd. 5, the amount due will be deducted from the value of the prize and the Lottery will satisfy or partially satisfy the debt on the prizewinner's behalf. If any cash remains after the Lottery has forwarded the proceeds of a cash prize to the Minnesota Department of Revenue, the prizewinner will be awarded the remaining cash.
2. For (a) the \$2,000 gift card to Freewheel Bike and one (1) \$1,000 Visa gift card prize, and (b) the \$2,000 gift card to Freewheel Bike and \$1,000 cash prizes, if the prizewinner is delinquent in the payment of Minnesota state taxes or owes a debt as defined in Minn. Stat. § 270A.03, subd. 5, the prizewinner will be given thirty (30) calendar days from the date the Lottery informed them of the existence of a debt in which to fully satisfy the debt, as determined by the Minnesota Department of Revenue. If the prizewinner fails to completely satisfy the debt within 30 days:
 - i If the amount due is less than or equal to any cash (or cash equivalent) portion of the prize, the Lottery will forward the cash portion of the prize to the Department of Revenue to satisfy the debt on the prizewinner's behalf. The prizewinner will then be awarded the non-cash prize and if any cash remains, the remaining cash.
 - ii If the amount due is greater than any cash (or cash equivalent) portion of the prize, the Lottery may liquidate all or part of the non-cash prize and forward any proceeds, along with any cash prize, to the Department of Revenue to satisfy or partially satisfy the debt on the prizewinner's behalf. If any cash or merchandise remains, the prizewinner will be awarded the remaining cash and/or merchandise.

4.3. Claim Period

- A. Prizes with a value of \$599 or less will be shipped to the address listed in the prizewinner's Account after the drawing in which they are awarded. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined in B. below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service mailing address, and for checking mnlottery.com to determine if a prize was returned to the Lottery.
- B. ~~All prizes in the True North Second Chance must be claimed within one (1) year of the date of the drawing at which the prize was awarded. If,~~

~~however, the one (1) year deadline is a Saturday, Sunday, or a day that Minnesota State Lottery offices are closed, a claim must be submitted by the close of business the following business day. The Lottery reserves the right to substitute prizes based on when the prize is claimed during the claim period. The Lottery will post the end of the claim period on mnlottery.com. Questions may be referred to the Lottery at (651) 635-8273, option 1, or cs.support@mnlottery.com. Prizewinners must contact the Lottery within one year of the drawing date regarding a lost, stolen, or misdirected prize. Failure to report a prize not received within one year will result in forfeiture of any prize won. All prizes in the True North Second Chance must be claimed within one (1) year of the date of the drawing from which the prize was awarded. For prizes of \$600 or more or inquiries regarding lost, stolen, or misdirected prizes, the claim period ends at the close of business on the last day of the claim period that Lottery offices are open. Lottery offices are closed for the holidays and events listed on mnlottery.com, and one or more Lottery offices may close unexpectedly due to weather or other unforeseen circumstances. The Lottery reserves the right to substitute prizes based on when the prize is claimed during the claim period. The Lottery will post the end of the claim period on mnlottery.com. Questions may be referred to the Lottery at (651) 635-8273, option 1, or cs.support@mnlottery.com. Prizewinners must contact the Lottery within one year of the drawing date regarding a lost, stolen, or misdirected prize. Failure to report a prize not received within one year will result in forfeiture of any prize won.~~

4.4. Allowance for Delay of Payment

The Lottery may delay payment pending a final determination by the Lottery under any of the following circumstances.

- A. if a dispute occurs or it appears likely that a dispute may occur regarding the prize;
- B. if a dispute occurs or it appears likely that a dispute may occur regarding the ownership of the entry;
- C. if there is any question regarding the identity of the claimant;
- D. if there is any question regarding the validity of the entry or the claim presented for payment; or
- E. if the claim is subject to any reduction for delinquent debts owed by the claimant under Minn. Stat. § 349A.08, subd. 8. No liability for interest for any delay will accrue to the benefit of the claimant pending payment of the claim.

4.5. **Emergency Termination**

If, for any reason, it is not possible to run all or any part of the True North Second Chance as planned due to, without limitation, errors in these official rules or advertising for this promotion, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Second Chance, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the promotion.

5.1. **Governing Law**

By submitting an entry to a Second Chance, a player agrees to comply with and abide by these game procedures: Minn. Stat. § 349A (State Lottery); Minn. R. 7857 (Lottery Prize Payments); and all final decisions of the Director of the Lottery. All applicable federal, state, or local laws apply. Second Chance offer void where prohibited by law.
