

Minnesota State Lottery Official Drawing Rules
“Minnesota United FC 2021 Event Giveaway”
7/24/21 – 10/31/21

1.1. Name of Promotion

The name of this Promotion is the “Minnesota United FC 2021 Event Giveaway.”

2.1. Definitions

- A. **“Tickets”** means any Minnesota State Lottery scratch or lotto game.
- B. **“Lottery”** means the Minnesota State Lottery.
- C. **“Minnesota United FC 2021 Event Giveaway”** or **“Promotion”** means the drawings conducted by the Lottery in conjunction with the Minnesota United FC 2021 Event Giveaway.

3.1. Duration

- A. The Promotion will begin at approximately 12:00 p.m. Central Time (“CT”) on July 24, 2021, and conclude at approximately 1:00 p.m. CT on October 31, 2021.

4.1. Eligibility

- A. A person may enter the Promotion by:
 - 1. Legibly completing the official entry form, including full name, U.S. Postal Service mailing address, including zip code, and phone number;
 - 2. Depositing the completed entry form into an official Minnesota Lottery drawing box located at the Lottery booth at Allianz Field during the times listed below.

The Lottery will announce and prominently display the Start and End times for entry at each Event.

- B. Each player may enter only once.
- C. The official entry form is the only acceptable form of entry. Incomplete entry information may result in disqualification. A facsimile or photocopy of the entry form is not an eligible entry. Entries are void if mutilated or illegible.
- D. Employees (including immediate family residing in the same household) of the Lottery, employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a

contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this drawing. Employees, officers, directors, members, managers, representatives, and agents of Minnesota United Soccer Club, LLC d/b/a Minnesota United FC (“MNUFC”), Major League Soccer, LLC (“MLS”), Soccer United Marketing, LLC (“SUM” and collectively with MNUFC and MLS, the “MLS Entities”) and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies and the immediate families (defined as parents, spouses, domestic partners, in-laws, children, siblings, grandparents, grandchildren, and their respective spouses) or members of the same household (whether related or not) of each such individual are not eligible to enter. Prizewinners will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.

- E. The person who submits an entry must be 18 years of age or older. No prize may be paid to a person under 18 years of age.
- F. By participating, players agree to these official rules and to the decisions of the Lottery which will be final and binding in all respects.
- G. An entry will be considered invalid if it does not meet all of the requirements for eligibility stated in this section.

5.1. Promotion Drawings

A. To enter the Minnesota United FC 2021 Event Giveaway, a player must enter via the process described above. The Lottery will conduct three (3) drawings. The eligibility and schedule for each drawing are below:

The Lottery will announce and prominently display the Start and End times for entry at each Event.

C. One (1) prizewinner for drawing #1 will be drawn at random by a Lottery representative on or about July 27, 2021.

One (1) prizewinner for drawing #2 and drawing #3 will be drawn at random by a Lottery representative on or about TBD.

- D. Three (3) prizes will be awarded. The prizewinners from drawings #1 through #3, will receive a prize pack consisting of \$100 in Lottery scratch tickets, one (1) Minnesota United FC Scarf, one (1) Lottery-logo water bottle, one (1) Lottery-logo bag and one (1) pair of Lottery-logo sunglasses. The taxable prize value is estimated at \$30. If a selected prizewinner resides outside the state of Minnesota, they will receive \$100 cash, one (1) Minnesota United FC Scarf, one (1) Lottery-logo water bottle, one (1) Lottery-logo bag, and one (1) pair of Lottery-logo sunglasses. The taxable prize value is estimated at \$130. The Lottery reserves the right to substitute prizes based on availability.
- E. A list of all prizewinners will be posted on the Event Winners page of mnlottery.com following the drawing and after winners have been verified. The list will remain on the Event Winners page for the duration of the Claim Period (as defined below).
- F. By entering this Promotion, prizewinners consent to full use of any and all information they provide on the entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery and the MLS Entities. Prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
- G. The prizes for the winners of drawings #1 through #3 will be shipped to the prizewinners at the address provided on their entry slips. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service mailing address, and for checking mnlottery.com to determine if a prize was returned to the Lottery.

- I. Following each drawing, all entries will be retained by the Lottery for a period of ninety (90) days.

6.1. **Claiming Prizes**

All prizes in the Promotion must be claimed within one (1) year of the date of the drawing at which the prize was awarded (the "Claim Period"). The Lottery will post the end of the claim period on mnlottery.com. Questions may be referred to the Lottery at (651) 635-8273, option 1, or cs.support@mnlottery.com. Prizewinners must contact the Lottery within one (1) year of the drawing date regarding a lost, stolen, or misdirected prize. Failure to report a prize not received within one (1) year will result in forfeiture of any prize won.

7.1. Allowance for Delay of Payment

The Lottery may delay payment pending a final determination by the Lottery under any of the following circumstances:

- A. if a dispute occurs or it appears likely that a dispute may occur regarding the prize;
- B. if a dispute occurs or it appears likely that a dispute may occur regarding the ownership of the entry;
- C. if there is any question regarding the identity of the claimant;
- D. if there is any question regarding the validity of the entry or the claim presented for payment; or
- E. if the claim is subject to any setoff for delinquent debts owed by the claimant under Minn. Stat. § 349A.08, subd. 8.

8.1. Emergency Termination

If, for any reason it is not possible to run all or any part of the Minnesota United FC 2021 Event Giveaway as planned due to, without limitation, errors in these official rules or advertising for this Promotion, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this

Promotion, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the Promotion.

9.1. **Governing Law**

By submitting an entry into the Minnesota United FC 2021 Event Giveaway, a player agrees to comply with and abide by these game procedures; Minn. Stat. § 349A (State Lottery Law); Minn. R. 7857 (Lottery Prize Payments); and all final decisions of the Director of the Lottery. All applicable federal, state, or local laws apply. Offer void where prohibited by law.
