

Minnesota State Lottery
Game Rules
Scratch Game #1810
“Diamond Bingo 2X”

Adopted June 2, 2020; Amended April 1, 2021

1.1. Name of the Game

The name of Scratch Game #1810 is Diamond Bingo 2X.

1.2. Ticket Price

- A. Each Ticket for Scratch Game #1810 costs three dollars (\$3.00).
- B. A retailer may discount the sales price of a Ticket in this game if the reduction in price is part of a storewide discount promotion on all purchases (Minnesota State Lottery [the “Lottery”] and non-Lottery) made by a player. The discount of the price does not relieve the retailer from the obligation to pay the Lottery the full price of a Ticket as stated in this section.

1.3. Definitions

- A. **“Bar Code”** means the unique bar-coded representation of the game Pack-Ticket Number and the Validation Number. The Bar Code is comprised of 14 decimal digits.
- B. **“Display Printing”** means the part of each Ticket outside of the area where the Play Symbols appear after the latex coating is scratched away.
- C. **“Pack”** means a Pack of fan-folded Diamond Bingo 2X Scratch Tickets that are separated by perforations the retailer tears when the retailer sells a Ticket. These fan-folded Tickets are packaged in plastic shrink-wrapping. A Pack consists of one hundred (100) Tickets fan-folded, bearing a common Pack Number and having a Ticket number starting at 000 and continuing through 099.
- D. **“Pack-Ticket Number”** means the 14-digit code printed in Pack-Ticket Number font in black ink upside-down on the bottom of the back of each Ticket in the form 1810-000001-000-1.
- E. **“Symbol”** means the images under the scratch-off area on the front of each Ticket. There are four (4) types of Symbols in the Diamond Bingo 2X Scratch Game:
 - 1. Doubler Symbols.
 - 2. Bonus Play Symbols.
 - 3. Bingo Card 1, Bingo Card 2, Bingo Card 3, and Bingo Card 4 Play Symbols.
 - 4. Caller’s Card Play Symbols.

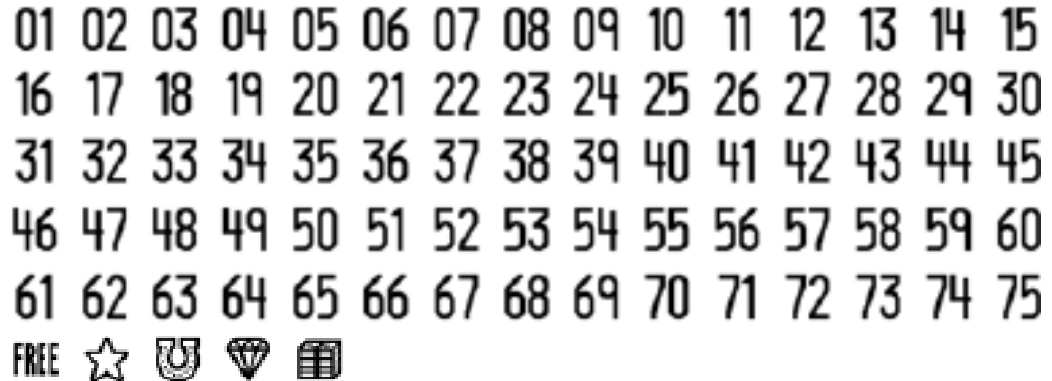
F. Doubler Symbols are printed in black ink, as shown below.



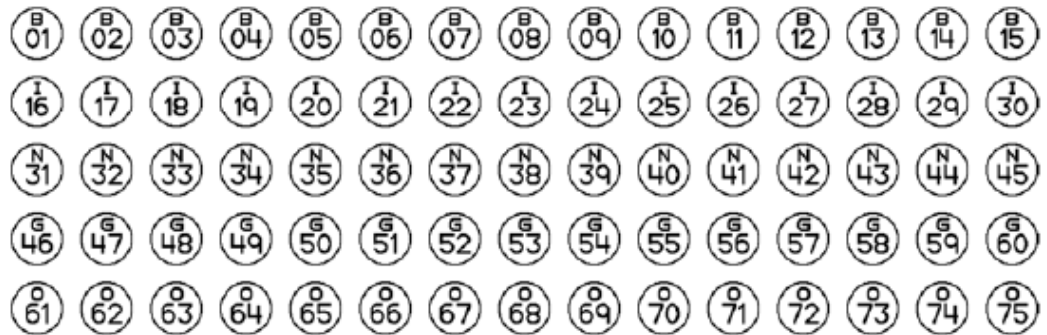
G. Bonus Play Symbols are printed in black ink, as shown below.



H. Bingo Card 1, Bingo Card 2, Bingo Card 3, and Bingo Card 4 Symbols are printed in black ink, as shown below.



I. Caller's Card Play Symbols are printed in black ink, as shown below.



J. "Ticket" or "Scratch Game Ticket" or "Scratch Ticket" means a Diamond Bingo 2X Scratch Game #1810 Ticket.

K. "Validation Number" means a game-wide, unique 10-digit Validation Number that is printed in Validation font (0 1 2 3 4 5 6 7 8 9) in black ink the Caller's Card play area on the front of the Ticket and covered with latex coating and overprinting graphic.


2.1. Determination of Prizewinners


A. The determination of prizewinners is subject to the general Ticket validation requirements set forth in Section 2 of these procedures; Minn. Stat. § 349A (Lottery Statute); Minn. R. 7857 (Lottery Prize Payments); and the requirements on the back of each Scratch Ticket.


B. To determine if a Ticket is a winning Ticket, the Bar Code printed under the latex below the Caller's Card play area on the front of the Ticket must be scanned into a terminal connected to the Lottery computer system that must verify that the Ticket is a winning Ticket and the prize level of the winning Ticket. The revealed Symbols on the front of the Ticket do


not determine if a Ticket is a winning Ticket. The revealable Symbols are for entertainment purposes only.

- C. There are four (4) Bingo cards in the Diamond Bingo 2X Scratch Game. Each Bingo card is played separately.
- D. An apparent prizewinner in the Diamond Bingo 2X Scratch Game is determined when the play area on the front of the Ticket is scratched off to reveal the Doubler Symbol, the Bonus Play Symbol, the twenty-five (25) Caller's Card Play Symbols, and the Bingo Card 1, Bingo Card 2, Bingo Card 3, and Bingo Card 4 Symbols that match the Caller's Card Play Symbols.

- E. The holder of a Ticket who reveals a  Symbol in the Bonus play area wins three dollars (\$3).





- F. The holder of a Ticket who reveals a  Symbol in the Bonus play area wins five dollars (\$5).

- G. The holder of a Ticket who reveals a  Symbol in the Bonus play area wins ten dollars (\$10).


- H. The holder of a Ticket who reveals a  Symbol in the Bonus play area wins twenty dollars (\$20).

- I. The holder of a Ticket whose Caller's Card Play Symbols match the Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4 Symbols in a horizontal, vertical, or diagonal line; four (4) corners; diamond pattern of four (4) numbers (including the FREE Symbol) in specified columns and rows for Bingo Cards 1 and 2 and diamond pattern of twelve (12) numbers (including the FREE Symbol) in specified columns and rows for Bingo Cards 3 and 4; or two (2) diagonal lines (forming an "X") in Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4 wins the amount indicated to the left of Bingo Card 1, the amount indicated to the right of Bingo Card 2, the amount indicated to the left of Bingo Card 3, and the amount indicated to the right of Bingo Card 4.

- J. The space in the third row of the N column on Bingo Card 1, Bingo Card 2, Bingo Card 3, and Bingo Card 4 with a FREE Symbol is deemed a match with a Caller's Card Play Symbol and may be used to complete a horizontal, vertical, or diagonal line or a diamond or X pattern.

- K. A , a , a , or a  Symbol in Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4 is deemed a match with any Caller's Card Number Symbol and may be used to complete a horizontal, vertical, or diagonal line; four corners; or diamond or X pattern.

- L. In Bingo Card 1, the possible prizes that may be won for matching a

complete horizontal, vertical, or diagonal line (); four corners

P. The holder of a ticket who wins a prize in Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4 and the winning pattern includes the ticket's revealed Doubler Symbol (upper left portion of ticket), wins two (2) times the prize indicated for the winning pattern for that Bingo Card. The top prize will not be doubled.

Q. No portion of the Display Printing or any extraneous matter is usable or playable as part of the Diamond Bingo 2X Scratch Game.

R. A player may win more than one prize on a ticket, but may not win more than one prize on each individual Bingo Card (Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4).

S. Only the highest winning prize of each Bingo Card (Bingo Card 1, Bingo Card 2, Bingo Card 3, or Bingo Card 4) will be paid. The Bonus instant win described in Sections E through H above, is excluded.

2.2. Scratch Ticket Validation Requirements

A. To be valid, a Diamond Bingo 2X Scratch Game Ticket must meet all the following requirements:

1. the Ticket must be intact;
2. the Ticket Validation and Pack-Ticket Numbers must be legible. These numbers are used by the Lottery in its official validation process to determine if the Ticket contains a winner and the prize level of a winning Ticket;
3. the Ticket must not be altered, reconstituted, or tampered with in any way;
4. The signature on the Ticket must not have been removed, or altered in any way;
5. the Ticket must not be counterfeit in any way in whole or in part;
6. the Ticket must have been issued by the Lottery in an authorized manner;

7. the Ticket must not have been stolen nor appear on any list of omitted Tickets or non-activated Tickets on file at the Lottery;
 8. the Validation Number of an apparent winning Ticket must be verified as a winning Ticket on the Lottery computer system and the Ticket must not have been previously paid; and
 9. the Ticket must not be printed or produced in error.
- B. The Ticket must pass all additional validation tests specified in these game rules, Minn. Stat. § 349A (Lottery Statute), Minn. R. 7857 (Lottery Prize Payments), and any confidential validation tests performed by the Lottery.
- C. Any Ticket not passing all the validation requirements is void and is ineligible for any prize.

2.3. Procedure for Claiming Prizes

- A. The Lottery is not responsible for lost or stolen Tickets. The Lottery recommends that players use registered mail to send Tickets and Ticket Claim forms to the Lottery and that players keep a copy of the front and back of any Ticket sent.
- B. To claim a prize of less than six hundred dollars (\$600) a player must sign the back of the Ticket in the signature area and present the winning Ticket to any Lottery retailer or to Lottery headquarters at 2645 Long Lake Rd, Roseville, MN, or mail the Ticket to the Lottery at the P.O. box address printed on the back of the Ticket. The Lottery retailer or Lottery staff will verify the claim and, if valid, make payment of the amount due the player and physically void the Ticket. If a Lottery retailer cannot verify a claim or does not have the funds on hand to pay a claim, the Lottery retailer will provide the player with a Ticket Claim form and instruct the player on how to file a claim with the Lottery. If the claim is validated by the Lottery, a check will be forwarded to the player in the amount due. In the event the claim is not validated by the Lottery, the claim will be denied, and the player will be notified promptly.
- C. To claim a prize of six hundred dollars (\$600) to fifty thousand dollars (\$50,000), a player must sign the winning Ticket, fill out a Ticket Claim form and present both the Ticket and the Ticket Claim form at any Lottery office or mail both to the Lottery at the P.O. box address printed on the back of the Ticket. If the claim is validated by the Lottery, a check will be forwarded to the player for payment in the amount due less any appropriate debt set-off under Minn. Stat. § 270A and any applicable federal and state withholding tax. If the claim is not validated by the Lottery, the claim will be denied, and the player will be notified promptly.

2.4. Allowance for Delay of Payment

The Lottery may delay payment of a prize pending a final determination by the Lottery under any of the following circumstances:

- A. if a dispute occurs or it appears likely that a dispute may occur regarding the prize;

- B. if a dispute occurs or it appears likely that a dispute may occur regarding the ownership of the Ticket;
- C. if there is any question regarding the identity of the claimant;
- D. if there is any question regarding the validity of the Ticket presented for payment; or
- E. if the claim is subject to any setoff for delinquent debts owed by the claimant under Minn. Stat. § 349A.08, subd. 8.

2.5. **Payment of Prizes to Persons Under Age 18**

No prize in the Diamond Bingo 2X Scratch Game may be paid to a person under 18 years of age.

2.6. **Scratch Ticket Claim Period**

~~All prizes must be claimed within one (1) year of the announced end of the game. If, however, the one (1) year deadline is a Saturday, Sunday, or a day that Minnesota State Lottery offices are closed, a claim must be submitted by the close of business the following business day.~~ All prizes must be claimed within one (1) year of the announced end of the game. For prizes claimed by mail, date of claim is date of receipt by the Lottery. The Lottery will announce the end of the game on mnlottery.com. For prizes of \$600 or more, the claim period ends at the close of business on the last day of the claim period that Lottery offices are open. Lottery offices are closed for the holidays and events listed on mnlottery.com, and one or more Lottery offices may close unexpectedly due to weather or other unforeseen circumstances.

3.1. **Scratch Ticket Ownership**

- A. Until the area designated for a signature on the back of a Ticket is signed, a Ticket is considered owned by the physical possessor of said Ticket. Removed or altered signatures may void a Ticket; the Ticket will be ineligible for any prize. When a Ticket is signed in the designated area, the player whose signature appears in the signature area is considered the owner of the Ticket and is entitled to any prize attributable thereto.
- B. Notwithstanding any name or names submitted on a claim form, the Director will make payment to the player whose signature appears on the back of the Ticket in the signature area. If more than one (1) name appears on the back of the Ticket in the signature area or more than one (1) person has agreed to share the prize and the prize being claimed is less than \$600, the Director will require that one (1) of those players whose name appears thereon or have agreed to share the prize be designated to receive payment. If more than one (1) name appears on the back of a Ticket or there is a valid agreement among more than one (1) person agreeing to share the prize and the prize being claimed is for \$600 or greater, the Director will make payment to each person who is a party to a valid prize-sharing agreement.
- C. The Lottery is not responsible for lost or stolen Tickets.

4.1. **Number and Value of Prizes**

There will be approximately 2,692,800 Tickets in the game. The expected number and value of prizes in the Diamond Bingo 2X Scratch Game are as follows:

The actual number of Tickets in the game may be increased or decreased at the sole discretion of the Lottery. The overall odds of winning a prize in the Diamond Bingo 2X Scratch Game are 1:3.83.

5.1. **Emergency Termination of the Game**

The Director may, at any time, announce the termination of the Diamond Bingo 2X Scratch Game without advance notice at which point no further Tickets in the Scratch Game may be sold.

6.1. **Governing Law**

In purchasing a Ticket, the player agrees to comply with and abide by Minn. Stat. § 349A (State Lottery); Minn. R. 7857 (Lottery Prize Payments), and all final decisions of the Director of the Lottery.
