

**Official Drawing Rules**  
**Minnesota State Lottery**  
**MN Whitecaps 2021 Online Giveaway**  
**January 4, 2021 – January 12, 2021**

1. To enter and be eligible to win, a player must:
  - A. have a registered account on and be logged in at [mnlottery.com](http://mnlottery.com)
  - B. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
  - C. have an account registration address within Minnesota or one of the four states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
  - D. click Submit in the MN Whitecaps 2021 Online Giveaway between 9:00:00 a.m. on January 4, 2021, and 11:59:59 p.m. on January 12, 2021 (any answer selected before clicking Submit has no bearing on the giveaway outcome)
  - E. be 18 years of age or older
  
2. Each player may enter only once.
  
3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this MN Whitecaps 2021 Online Giveaway. The Prizewinner will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.
  
4. The prizewinner will be drawn at random from all eligible entries at Lottery headquarters by a Lottery representative on or about January 14, 2021. The prizewinner will be notified via email. The name and the city of the prizewinner will be posted on [mnlottery.com](http://mnlottery.com) following prizewinner verification. After verification, merchandise prizes will be shipped to the address provided in the prizewinner’s registered account on [mnlottery.com](http://mnlottery.com). If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.
  
5. The Lottery will conduct one (1) drawing.

The one (1) prizewinner drawn will receive one (1) Minnesota Whitecaps jersey, \$50 in Lottery scratch tickets, one (1) Lottery-logo duffel bag, one (1) Lottery-logo knit hat, one (1) Lottery-logo mug, one (1) Lottery-logo keychain, and one (1) Lottery-logo blanket. The taxable prize value is estimated at \$120.

If the prizewinner resides outside of Minnesota, their scratch ticket prize will be converted to cash. The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

6. By entering this giveaway, the prizewinner consents to full use of any and all information they provide on their account registration for publicity, public relations, and content creation purposes, including on Lottery social media channels and [mnlottery.com](http://mnlottery.com), by the Lottery. The Prizewinner may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

7. Odds of winning will be determined by the total number of entries received.

8. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
