

**Minnesota State Lottery**  
**“Prize Piggy” Second Chance**  
**May 7, 2019; Amended December 18, 2019**

**1.1. Definitions**

- A. **“Prize Piggy,” “Scratch Ticket” or “Ticket”** means the Minnesota Lottery Scratch Game #759.
- B. **“Prize Piggy Second Chance”** means an additional opportunity to win through a drawing conducted by the Minnesota Lottery in conjunction with the purchase of a Prize Piggy Scratch Ticket.
- C. **“The Lottery”** means the Minnesota State Lottery.
- D. **“Prize Piggy Second Chance Promotion” or “Second Chance Promotion” or “Second Chance”** means the drawings conducted by the Lottery in conjunction with the Prize Piggy Second Chance Promotion.
- E. **“Account”** means a player has registered at mnlottery.com with all required personal contact information.

**2.1. Duration**

The Prize Piggy Second Chance will begin at 5:00:00 a.m. Central Time (“CT”) on May 7, 2019, and conclude at 11:59:59 p.m. CT on January 7, 2020.

**3.1. Eligibility**

- A. A player may enter the Prize Piggy Second Chance by creating or having an Account at mnlottery.com, supplying all required registration information completely and in its entirety, and entering the 10-digit validation number found under the scratch-off latex coating of a non-winning Prize Piggy Scratch Ticket. Incomplete registration information may result in entry disqualification.
- B. Each non-winning Ticket entered will receive one (1) entry in the Prize Piggy Second Chance.
- C. Only one (1) winner per household per drawing is allowed.
- D. The submission of a winning Ticket invalidates that entry.
- E. Employees (including immediate family residing in the same household) of the Lottery, employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this Prize Piggy Second Chance.
- F. A player who submits an entry must be 18 years of age or older.

- G. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.
- H. A player may enter more than once; however, a player may use only one (1) unique Ticket number per entry. Multiple entries using the same non-winning Ticket number and entries made via automated computer scripts or other programming techniques will be disqualified.
- I. A player who uses a non-winning Ticket as an entry in this Prize Piggy Second Chance that has previously been used in any other Minnesota Lottery Second Chance, sweepstakes, or contest will be considered ineligible.
- J. By participating, players agree to these official rules and to the decisions of the Lottery which will be final and binding in all respects.
- K. An entry will be considered invalid if it does not meet all requirements for eligibility stated in this section.

**4.1. Prize Piggy Second Chance Drawings**

- A. To enter the Prize Piggy Second Chance, a player must enter a non-winning Ticket via the process described above. The Lottery will conduct two (2) Prize Piggy Second Chance drawings. The eligibility and schedule for each drawing are listed in the table below.

- B. The Lottery will, by use of mechanical or other devices, randomly determine which of the entries submitted are selected.
- C. The Lottery will conduct two (2) drawings at Lottery Headquarters. A Lottery representative will draw twenty-one (21) total winners for the following prizes:
  - Twenty (20) prizes of a \$100 Visa gift card and a Piggy bank (\$120 taxable value)

- One (1) prize of \$1,000 cash.

The Lottery reserves the right to substitute prizes for any reason, including based on availability.

- D. Each entry drawn in Drawing #1 will receive a \$100 Visa Gift Card and a Piggy Bank.
- E. The first entry drawn in Drawing #2 will receive \$1,000 cash; the next ten (10) entries drawn will each receive a \$100 Visa Gift Card and a Piggy Bank.
- F. A player may win only once in each Prize Piggy Second Chance drawing, but may win a prize in more than one drawing.
- G. A list of all prizewinners will be posted on the Winners page of [mnlottery.com](http://mnlottery.com) following the drawing and after prizewinners have been verified. The list will remain on the Winners page for the duration of the Claim Period (as defined below).
- H. By entering the Prize Piggy Second Chance, prizewinners consent to full use of any and all information they provide on the entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and [mnlottery.com](http://mnlottery.com), by the Lottery. Prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

#### 4.2. **Claiming Prizes**

- A. A prize won in a Second Chance may not be assigned or transferred to another person. A merchandise or experiential prize may not be shared with another person under a prize-sharing agreement. A cash prize of \$600 or more may be split with another person under a prize-sharing agreement. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply.
- B. Prizes with a value of \$599 or less will be shipped to the address listed in the prizewinner's Account after the drawing in which they are awarded. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service

mailing address, and for checking [mnlottery.com](http://mnlottery.com) to determine if a prize was returned to the Lottery.

- C. Each player whose entry was selected in a Second Chance drawing to win a prize valued at \$600 or more must fill out and submit a claim form to the Lottery. If the claim is not validated by the Lottery, the claim will be denied, and the player will be notified immediately. If a prizewinner is delinquent in the payment of Minnesota state taxes or owes a debt as defined in Minn. Stat. § 270A.03, subd. 5, the amount due will be deducted from the value of the prize including, but not limited to, the cash portion of the prize, and the cash value of the merchandise or non-cash prizes. If the prizewinner owes a debt as described above, they will be given thirty (30) calendar days from the date the Lottery informed them of the existence of a debt in which to fully satisfy the debt, as determined by the Minnesota Department of Revenue. If the prizewinner fails to completely satisfy the debt within 30 days, the Lottery will liquidate the non-cash prize and forward any proceeds received to the Department of Revenue to satisfy or partially satisfy the debt on the prizewinner's behalf. If any cash remains after the Lottery has forwarded the proceeds of a non-cash prize to the Minnesota Department of Revenue, the prizewinner will be awarded the remaining cash.

#### 4.3. **Claim Period**

- A. Prizes with a value of \$599 or less will be shipped to the address listed in the prizewinner's Account after the drawing in which they are awarded. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined in B. below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service mailing address, and for checking [mnlottery.com](http://mnlottery.com) to determine if a prize was returned to the Lottery.
- B. All prizes in the Prize Piggy Second Chance must be claimed within one (1) year of the date of the drawing at which the prize was awarded. If, however, the one (1) year deadline is a Saturday, Sunday, or a day that Minnesota State Lottery offices are closed, a claim must be submitted by the close of business the following business day. The Lottery reserves the right to substitute prizes based on when the prize is claimed during the claim period. The Lottery will post the end of the claim period on [mnlottery.com](http://mnlottery.com). Questions may be referred to the Lottery at (651) 635-8273, option 1, or [cs.support@mnlottery.com](mailto:cs.support@mnlottery.com). Prizewinners must contact the Lottery within one year of the drawing date regarding a lost, stolen, or misdirected prize. Failure to report a prize not received within one year will result in forfeiture of any prize won.

#### 4.4. **Allowance for Delay of Payment**

The Lottery may delay payment pending a final determination by the Lottery under any of the following circumstances.

- A. if a dispute occurs or it appears likely that a dispute may occur regarding the prize;
- B. if a dispute occurs or it appears likely that a dispute may occur regarding the ownership of the entry;
- C. if there is any question regarding the identity of the claimant;
- D. if there is any question regarding the validity of the entry or the claim presented for payment; or
- E. if the claim is subject to any reduction for delinquent debts owed by the claimant under Minn. Stat. § 349A.08, subd. 8. No liability for interest for any delay shall accrue to the benefit of the claimant pending payment of the claim.

#### 4.5. **Emergency Termination**

If, for any reason, it is not possible to run all or any part of the Prize Piggy Second Chance as planned due to, without limitation, errors in these official rules or advertising for this promotion, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity or proper conduct of this Second Chance, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the promotion.

#### 5.1. **Governing Law**

By submitting an entry to a Second Chance, a player agrees to comply with and abide by these game procedures: Minn. Stat. § 349A (State Lottery); Minn. R. 7857 (Lottery Prize Payments); and all final decisions of the Director of the Lottery. All applicable federal, state, or local laws apply. Second Chance offer void where prohibited by law.
