

MINNESOTA STATE LOTTERY
Giveaway
October 8–October 29, 2019
“Gopher Men’s Hockey Giveaway”

1. To enter and be eligible to win, a player must: a) have a registered account on and be logged in at mnlottery.com; b) have completed the full address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (to be used for receipt of any prize won); c) have an account registration address within Minnesota or one of the four states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin); d) entered the Gopher Men’s Hockey Giveaway between 12:00:00 a.m. on October 8, 2019, and 11:59:59 p.m. on October 29, 2019 (answer selected has no bearing on the giveaway outcome); and e) be 18 years of age or older.
2. Each player may enter only once.
3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Gopher Men’s Hockey Giveaway. The prizewinner will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.
4. The prizewinner will be drawn at random from all eligible entries at Lottery headquarters by a Lottery representative on or about October 31, 2019. The prizewinner will be notified via email. The name and the city of the prizewinner will be posted on mnlottery.com following prizewinner verification. If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.
5. The Lottery will conduct one (1) drawing.

The first prizewinner drawn will receive a Gopher Men’s Hockey prize pack that includes two (2) tickets to the Minnesota Gophers vs. University of North Dakota Fighting Hawks hockey game on November 29, 2019, at 3M Arena at Mariucci and one (1) night stay at the Graduate Hotel on the University campus in Minneapolis. The winner will also receive a \$100 Goldy’s Locker Room gift card, and \$100 in Lottery scratch tickets. The taxable prize value is estimated at \$1,100.

One prizewinner per household.

If the prizewinner resides outside of Minnesota, their scratch ticket prize will be converted to cash. The Lottery reserves the right to substitute prizes based on

availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

The person whose entry is selected in the Giveaway drawing to win a prize must fill out and submit a claim form to the Lottery within five (5) days. If the claim is not validated by the Lottery, the claim will be denied, and the player will be notified immediately.

If a prizewinner is delinquent in the payment of Minnesota state taxes or owes a debt as defined in Minn. Stat. § 270A.03, subd. 5, the amount due will be deducted from the value of the prize including, but not limited to, the cash portion of the prize, and the cash value of the merchandise or non-cash prizes. If the prizewinner owes a debt as described above, they will be given ten (10) calendar days from the date the Lottery informed them of the existence of a debt in which to fully satisfy the debt, as determined by the Minnesota Department of Revenue. If the prizewinner fails to completely satisfy the debt within ten (10) days, the Lottery will liquidate the non-cash prize and forward any proceeds received to the Department of Revenue to satisfy or partially satisfy the debt on the prizewinner's behalf. If any cash remains after the Lottery has forwarded the proceeds of a non-cash prize to the Minnesota Department of Revenue, the prizewinner will be awarded the remaining cash.

Prizes may be shipped to the address listed in the prizewinner's Minnesota Lottery Account profile after the drawing in which they are awarded. The Lottery is not responsible for lost or misdirected delivery. Prizes returned to the Lottery may be claimed by the prizewinner during the Claim Period (as defined below). The prizewinner is responsible for providing their correct contact information and U.S. Postal Service mailing address, and for checking mnlottery.com to determine if a prize was returned to the Lottery.

6. By entering this giveaway, the prizewinner consents to full use of any and all information they provide on their account registration for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. The prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

7. Odds of winning will be determined by the total number of entries received.

8. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.

If, for any reason it is not possible to run all or any part of the Gopher Men's Hockey Giveaway as planned due to, without limitation, errors in these official rules or advertising for this giveaway, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgement of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this giveaway, the Lottery reserves the right at its sole discretion, to cancel, terminate, modify, or suspend the giveaway.
