

**Official Drawing Rules**  
**Minnesota State Lottery**  
**Timberwolves 2021 Part 2 Online Giveaway**  
**February 23, 2021–June 1, 2021**

1. To enter and be eligible to win, a player must:
  - A. have a registered account on and be logged in at [mnlottery.com](http://mnlottery.com)
  - B. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
  - C. have an account registration address within Minnesota or one of the four states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
  - D. click Submit in the Timberwolves 2021 Part 2 Online Giveaway between 9:00:00 a.m. on February 23, 2021, and 11:59:59 p.m. on June 1, 2021 as specified in the drawing table below (any answer selected before clicking Submit has no bearing on the giveaway outcome)
  - E. be 18 years of age or older
2. Each player may enter only once in each drawing.
3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Timberwolves 2021 Part 2 Online Giveaway. Prizewinners will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.
4. The prizewinners will be drawn at random from all eligible entries at Lottery headquarters by a Lottery representative as set out in the table below. The prizewinners will be notified via email. The names and the cities of the prizewinners will be posted on [mnlottery.com](http://mnlottery.com) following prizewinner verification. After verification, merchandise prizes will be shipped to the address provided in the prizewinner’s registered account on [mnlottery.com](http://mnlottery.com). If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.
5. The Lottery will conduct four (4) drawings at Lottery Headquarters. The first prizewinner drawn in each drawing will receive a Timberwolves/Lottery Prize pack. A Lottery representative will draw one (1) winner for each of the following four (4) prizes:

- Drawing #1: One (1) prize of an Autographed Anthony Edwards basketball and other Timberwolves merchandise, Lottery-logo duffle bag, I'MN hoodie, and \$100 in scratch tickets (\$250 taxable value)
- Drawing #2: One (1) prize of an Autographed Jarrett Culver Timberwolves hat and other Timberwolves merchandise, Lottery-logo duffle bag, I'MN hoodie, and \$100 in scratch tickets (\$150 taxable value)
- Drawing #3: One (1) prize of an Autographed Josh Okogie mini-basketball and other Timberwolves merchandise, Lottery-logo duffle bag, I'MN hoodie, and \$100 in scratch tickets (\$150 taxable value)

mnlottery.com, by the Lottery. Prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

7. Odds of winning will be determined by the total number of entries received.

8. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
