

Official Drawing Rules
Minnesota State Lottery
Win Minnesota United Tix Online Giveaway
June 24, 2021–July 6, 2021; revised June 29, 2021

1. To enter and be eligible to win, a player must:
 - A. have a registered account on and be logged in at mnlottery.com
 - B. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
 - C. have an account registration address within Minnesota or one of the four states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
 - D. click Submit in the Win Minnesota United Tix Online Giveaway between 9:00:00 a.m. on June 24 2021, and 11:59:59 p.m. on July 6, 2021 (any answer selected before clicking Submit has no bearing on the giveaway outcome)
 - E. be 18 years of age or older

2. Each player may enter only once.

3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Win Minnesota United Tix Online Giveaway. Employees, officers, directors, members, managers, representatives, and agents of Minnesota United Soccer Club, LLC d/b/a Minnesota United FC (“MNUFC”), Major League Soccer, LLC (“MLS”), Soccer United Marketing, LLC (“SUM” and collectively with MNUFC and MLS, the “MLS Entities”) and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies and the immediate families (defined as parents, spouses, domestic partners, in-laws, children, siblings, grandparents, grandchildren, and their respective spouses) or members of the same household (whether related or not) of each such individual are not eligible to enter. 4. The prizewinners will be drawn at random from all eligible entries at Lottery headquarters by a Lottery representative on or about July 8, 2021. The prizewinners will be notified via email. The names and the cities of the prizewinners will be posted on mnlottery.com following prizewinner verification. After verification, tickets will be transferred electronically to the email address provided in the prizewinner’s registered account on mnlottery.com. Merchandise prizes will be shipped to the address provided in the prizewinner’s registered account on mnlottery.com. If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the

prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.

5. The Lottery will conduct one (1) drawing.

The first 12 prizewinners drawn will receive four (4) tickets for the Minnesota United home game on July 24, four (4) lottery t-shirts, and four (4) soccer ball key chains. The taxable prize value is estimated at \$160.

One prizewinner per household.

The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

6. By entering this giveaway, prizewinners consent to full use of any and all information they provide on their account registration for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery and the MLS Entities. Prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

7. Odds of winning will be determined by the total number of entries received.

8. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
