

**Official Rules
Minnesota State Lottery
Instagram Sweepstakes
Whoa-quet Social Sweepstakes
Wednesday, February 10, 2021**

1. To be eligible to win a player must:
 - A. be a registered member of Instagram (<http://www.instagram.com/>);
 - B. be 18 years of age or older;
 - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
 - D. have commented “TMN” on the Minnesota Lottery Instagram Whoa-quet Social Sweepstakes post between 12:00 a.m. central time (“CT”) on Wednesday, February 10, 2021, and 11:59 p.m. (CT) on Wednesday, February 10, 2021.
2. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.
3. The prizewinners will be drawn at random from all eligible entries at Lottery Headquarters by Lottery representatives on or about Thursday, February 11, 2021. The name and city of the prizewinners may be posted on mnlottery.com and/or Lottery social media channels following prizewinner verification.
4. One (1) drawing will occur, and one (1) prize will be awarded. The prizewinner will receive six (6) Triple Diamond scratch tickets, eleven (11) True North™ scratch tickets, eleven (11) Joker’s Wild Crossword scratch tickets, ten (10) Did I Win? scratch tickets, one (1) vase, one (1) bouquet of flowers, one (1) red chocolate heart, one (1) chocolate lollipop, one (1) heart truffle, three (3) chocolate hearts, one (1) fish chocolate, one (1) Minnesota chocolate, two (2) hearts enclosed in foil, and vase-filler beads. The approximate taxable prize value is \$251. The Lottery reserves the right to substitute or omit prizes for any reason, including availability. A prizewinner may win only once. One winner per household. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
5. The Lottery will use information provided on winning sweepstakes entry forms to verify the winners. Incomplete information may result in entry disqualification. If the Lottery is unable to verify a winning entry, the Lottery will deem it ineligible and the player will not be entitled to any prize.

6. Prizes will be shipped to the U.S. Postal Service mailing address provided in the Winner Affidavit form following verification. If a prize is returned to the Lottery, the Lottery may declare the prize forfeited by the player and the player will have no further right to the prize and the Lottery may award the prize to another player.
7. By entering this sweepstakes, prizewinners consent to full use of any and all information they provide on the entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
8. The odds of winning are determined by the total number of entries received.
9. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
10. This sweepstakes begins at 12:00 a.m. CT on Wednesday, February 10, 2021 and concludes at 11:59 p.m. CT on Wednesday, February 10, 2021.
