

Official Rules
Minnesota State Lottery
Twitter Sweepstakes
“#IMN4Nature Social Sweepstakes”
Thursday, August 27th–Friday, August 28th, 2020

1. To be eligible to win a player must:
 - A. be a registered member of Twitter (www.twitter.com);
 - B. be 18 years of age or older;
 - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
 - D. have created a tweet with “#IMN4Nature” between 12:00 p.m. central time (“CT”) on Thursday, August 27th, 2020, and 12:00 p.m. central time (“CT”) on Friday, August 28th, 2020.
2. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.
3. The prizewinners will be drawn at random from all eligible entries at Lottery Headquarters by Lottery representatives on or about Monday, August 31st, 2020. The name and city of the prizewinners may be posted on mnlottery.com and/or Lottery social media channels following prizewinner verification.
4. One (1) drawing will occur, and five (5) prize packages will be awarded. Each prizewinner will receive one (1) University of Minnesota–logo baseball cap, one (1) Minnesota Lottery–logo Gopher 5 sweatshirt and twenty dollars (\$20) in Nuts for Cash scratch tickets. The approximate taxable value of the prize is \$28.00. The Lottery reserves the right to substitute or omit prizes based on availability. A prizewinner may win only once. One winner per household. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
5. The Lottery will use information provided on winning Electronic Prizewinners Affidavit forms to verify the winners. Incomplete information may result in entry disqualification. If the Lottery is unable to verify a winning entry, the Lottery will deem it ineligible and the player will not be entitled to any prize.
6. Prizes will be shipped to the U.S. Postal Service mailing address provided in the Electronic Prizewinner Affidavit form following verification. If a prize is returned to the Lottery, the Lottery may declare the prize forfeited by the player and the player will have no further right to the prize and the Lottery may award the prize to another player.

7. By entering this sweepstakes, prizewinners' consent to full use of any and all information they provide on the entry form for publicity, public relations, and content creation purposes, including on the Lottery's social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute an Affidavit of Eligibility form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
8. The odds of winning are determined by the total number of entries received.
9. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
10. This sweepstakes begins at 12:00 p.m. CT on Thursday, August 27th, 2020, and concludes at 12:00 p.m. CT on Friday, August 28th, 2020.

If, for any reason it is not possible to run all or any part of the #IMN4Nature Social Sweepstakes as planned due to, without limitation, errors in these official rules or advertising for this sweepstakes, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this sweepstakes, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the sweepstakes.
