

Official Rules
Minnesota State Lottery
Winners' Circle 2021 Social Sweepstakes
Thursday, April 1, 2021–Wednesday, October 13, 2021

1. To be eligible to win a player must:
 - A. be 18 years of age or older;
 - B. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
 - C. have completed the entry form on the Minnesota Lottery Winners' Circle 2021 Social Sweepstakes page (www.mnlottery.com/winnerscircle) between 12:00 a.m. central time ("CT") on Thursday, April 1, 2021, and 11:59 p.m. (CT) on Tuesday, October 13, 2021. The entry page will generally be available and entries will be accepted during broadcasts of Minnesota Twins baseball games, and during other periods as determined by the Lottery.
2. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the "Lottery"), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.
3. A total of eighty-one (81) prizewinners will be drawn at random from all eligible entries at Lottery Headquarters by Lottery representatives in four (4) drawings.

Twenty (20) prizewinners will be drawn at random by a Lottery representative on or about May 13, 2021, from all eligible entries received from the Winners' Circle 2021 Social Sweepstakes between April 1, 2021 and May 12, 2021.

Twenty (20) prizewinners will be drawn at random by a Lottery representative on or about July 1, 2021, from all eligible entries received from the Winners' Circle 2021 Social Sweepstakes between May 13, 2021 and June 30, 2021.

Twenty (20) prizewinners will be drawn at random by a Lottery representative on or about August 19, 2021, from all eligible entries received from the Winners' Circle 2021 Social Sweepstakes between July 1, 2021 and August 18, 2021.

Twenty-one (21) prizewinners will be drawn at random by a Lottery representative on or about October 14, 2021, from all eligible entries received from the Winners' Circle 2021 Social Sweepstakes between August 19, 2021 and October 13, 2021.

The name and city of the prizewinners may be posted on mnlottery.com and/or Lottery social media channels following prizewinner verification.

4. Four (4) drawings will occur, and eighty-one (81) prizes will be awarded. Each prizewinner will receive \$50 in Lottery scratch tickets, one (1) Lottery PMN T-shirt, one (1) Lottery-logo baseball keychain, and one (1) Lottery and Twins cobranded steel tumbler. The approximate taxable prize value is \$0. The Lottery reserves the right to substitute or omit prizes for any reason, including availability. A prizewinner may win only once. One winner per household. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
5. The Lottery will use information provided on winning Sweepstakes entry forms to verify the winners. Incomplete information may result in entry disqualification. If the Lottery is unable to verify a winning entry, the Lottery will deem it ineligible and the player will not be entitled to any prize.
6. Prizes will be shipped to the U.S. Postal Service mailing address provided in the Winner Affidavit form following verification. If a prize is returned to the Lottery, the Lottery may declare the prize forfeited by the player and the player will have no further right to the prize and the Lottery may award the prize to another player.
7. By entering this sweepstakes, prizewinners consent to full use of any and all information they provide on the entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
8. The odds of winning are determined by the total number of entries received.
9. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
10. This sweepstakes begins at 12:00 a.m. CT on Thursday, April 1, 2021, and concludes at 11:59 p.m. CT on Wednesday, October 13, 2021.

If, for any reason it is not possible to run all or any part of the Winners' Circle 2021 Social Sweepstakes as planned due to, without limitation, errors in these official rules or advertising for this sweepstakes, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this sweepstakes, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the sweepstakes.
