

Official Rules
Minnesota State Lottery
Corn Maze Live Stream Social Sweepstakes
Friday, October 29, 2021

1. To be eligible to win a player must:
 - A. be a registered member of Facebook (www.facebook.com);
 - B. be 18 years of age or older;
 - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
 - D. have commented during the Corn Maze Live Stream on the Minnesota Lottery Facebook page while it is live between approximately 11:00 a.m. central time (“CT”) on Friday, October 29, 2021, and approximately 11:30 a.m. (CT) on Friday, October 29, 2021.
2. Any entry or portion of an entry that demeans, defames, or ridicules others, contains profanity or illegal activity, or is not in the best interest of the Minnesota Lottery or its marketing may be deleted and disqualified from this Social Sweepstakes.
3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.
4. The first person to comment after the Minnesota Lottery makes a comment after finding a check point during the live stream will be a prizewinner. The name and city of the prizewinners may be posted on mnlottery.com and/or Lottery social media channels following prizewinner verification.
5. Up to five (5) prizewinners will be selected, The number of prizewinners is dependent on how many check points are reached during the live stream. Each prizewinner, if validated, will receive twenty dollars (\$20) in Minnesota Lottery Fall Winnings scratch game tickets, one (1) Minnesota Lottery I’MN long sleeve T-shirt and one (1) Minnesota Lottery Kona coffee mug. The approximate taxable prize value is \$0. The Lottery reserves the right to substitute or omit prizes for any reason, including availability. A prizewinner may win only once. One (1) prizewinner per household. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
6. The Lottery will request personal information to validate each prizewinner. Incomplete information may result in entry disqualification. If the Lottery is unable to validate a winning entry, the Lottery will deem it ineligible and the

player will not be entitled to any prize.

7. If the Lottery is unable to make contact with a prizewinner within three (3) days after the message is sent, the Lottery may declare the prize to be forfeited by the prizewinner and the prizewinner will have no further right to the prize, and the Lottery may award the prize to an alternate. By entering this sweepstakes, a prizewinner consents to the full use of their name and city for publicity and public relations purposes.
8. Prizes will be shipped to the U.S. Postal Service mailing address provided by the prizewinner. If a prize is returned to the Lottery, the Lottery may declare the prize forfeited by the player and the player will have no further right to the prize and the Lottery may award the prize to another player.
9. By entering this sweepstakes, prizewinners consent to full use of any and all information they provide for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners will be required to execute appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
10. The odds of winning are determined by the total number of entries received.
11. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.
12. This sweepstakes begins at approximately 11:00 a.m. central time ("CT") on Friday, October 29, 2021, and ends at approximately 11:30 a.m. (CT) on Friday, October 29, 2021.

If, for any reason it is not possible to run all or any part of the Corn Maze Social Sweepstakes as planned due to, without limitation, errors in these official rules or advertising for this sweepstakes, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this

sweepstakes, the Lottery reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the sweepstakes.
